## Artificial Insemination and Shipped Semen Stallion Service Contract

It is agreed to breed the mare \_\_\_\_\_ Reg. No. \_\_\_\_\_  
To the stallion **DRIFTWOOD ETC.** Reg. No # **3465999**  
For the **20** \_\_\_\_\_ breeding season.

Artificial insemination and or cooled shipped semen, stallion service fee: \$ 650.00, \$ 150.00 booking fee is included. For the total amount of \$ 650.00, of which \$ 150.00 must be pre paid, and sent with signed breeding contract, along with a copy of mares registration papers. Remaining balance of \$ 500.00, plus all other fees are due in full prior to insemination or shipment of cooled semen or, at time of mare pick up.

On site insemination available by AI technician.

When using the Equine Express 11 shipping container, Equitainer deposit fee is \$ 35.00, Plus Fed X Equitainer shipping cost of \$ 100.00.

All Equitaners must be returned in complete and clean condition. Equitainer deposit will be refunded when it arrives back in above said condition.

The stallion owner or agent may have mare checked by veterinarian for normal breeding condition, only if mare owner or agent is notified, and agrees. The cost of which mare owner or agent shall pay. The mare owner or agent is responsible for all veterinarian costs and any medications given to said mare, or mares. Stallion owner or agent shall assume no liability for mares that will not breed, cannot conceive, or for accident, sickness or death of said mare or colt, but will exercise every reasonable effort to settle mare and use good judgment in care and supervision of mare or mares and colt. Mare owner shall not be responsible for injury or accident to stallion.

**LFG.** If mare fails to conceive and mare owner elects to rebreed the same mare the following year, the mare owner or agent will pay a \$200.00 chute fee, and all other mare care fees and or shipping costs for shipped semen. All mares must be current on vaccinations before arriving to the breeding farm.

Mare owner or agent is responsible for his or her shipped semen paperwork. There will be a copy that is to be sent in for (each horse) to registration department within 10 days of inseminating mare or mares. You will receive this with your semen shipment.

All mares must be halter broke or they will not be accepted.

Mare care is at the cost of \$ 9.00 per day, any mare or mares left at the breeding farm for 15 days or more will automatically be charged a boarding fee of \$ 250.00
